## **TERMS AND CONDITIONS**

This version of the Terms and Conditions applies to participants in the Republic of South Africa.
- 4. We have a duty, in terms of the Consumer Protection Act, No 68 of 2008 ("CPA") to point out certain important provisions in these Terms and Conditions to you. The clauses which contain these important provisions and the reasons why they are important are set out below. It is very important that you read all these clauses carefully.
- 5. The Promotion is only valid in South Africa and is open to South African residents and South African citizens only. Participants must be in possession of a valid identity document or passport and must be aged 18 (eighteen) years or over.
