2. MiniPOS is a company incorporated in South Africa with a registration number: 014/250994/07, and whose registered office is situated at Fairland, Gauteng, RSA.
3. These Terms and Conditions will prevail in the event of any conflict or inconsistency with any other communications sent to you by us, including advertising or promotional materials. 9. Entry mechanic/How to enter
